

FANHS (Filipino American National Historical Society)

Volunteer Agreement and Release From Liability

1. I desire to perform volunteer services for the Filipino American National Historical Society (FANHS). I understand that FANHS sponsors family-oriented events. As a condition of my participation as a volunteer, I agree not to be under the influence of alcohol or illegal drugs while performing my volunteer services.
2. I acknowledge that as a volunteer for FANHS, I will not be paid, and my work is merely voluntary and gratuitous.
3. I acknowledge, understand and declare that: a) to the best of my knowledge, I am in GOOD PHYSICAL CONDITION and have no disease of injury that would be aggravated by participating as a volunteer; b) participating as a volunteer may involve RISK OF INJURY TO ME OR MY PROPERTY, or other consequences which might result not only from my own actions, inaction or negligence, but also from the actions, inactions or negligence of others, or the conditions of the premises or of any equipment used; c) there may be OTHER RISKS not known or not reasonably foreseeable.
4. I agree that: a) prior to participating as a volunteer, I will INSPECT the facilities and equipment I will be involved with, and if I believe same to be unsafe, I will immediately REPORT such condition(s) to the designated FANHS Volunteer Coordinators and either DECLINE TO PARTICIPATE or ASSUME THE RISK of volunteering; b) I will allow my PHOTOGRAPH, PICTURE OR LIKENESS and/or VOICE to APPEAR in any official documentary, promotional, television, radio or film coverage of the activities of the Filipino American National Historical Society WITHOUT COMPENSATION; c) if I drive a vehicle in connection with my volunteer services, I acknowledge that I have a valid driver's license and agree that I must and will maintain automobile liability insurance with limits of liability consistent with the requirements of California law.
5. I consent to ALL EMERGENCY MEDICAL TREATMENT as may be deemed appropriate under existing circumstances by medical personnel.
6. RELEASE/INDEMNITY. As a consideration for the opportunity to volunteer for FANHS herein, I hereby release, discharge and waive any and all claims, demands, actions or liabilities that I now have or may hereafter have for injury, damages or other relief of any kind whatsoever resulting from or in any way related to my volunteer work with FANHS. I further agree that I will not make a claim against or sue FANHS, their respective Executive Director, Board of Trustees, local FANHS Officers, City of San Diego, affiliates, subsidiaries, employees, other volunteers, representatives or agents for any injury, damage or other relief, resulting from or in any way related to my volunteer work with FANHS. I hereby agree to indemnify, defend and hold harmless FANHS, their respective Executive Director, Board of Trustees, local FANHS Officers, City of San Diego, affiliates, subsidiaries, employees, other volunteers, agents, representatives, successors and assigns, from any claim, demands, actions or liabilities, including attorneys' fees and costs, should I take any action in violation of the provisions of this agreement.
7. KNOWING AND VOLUNTARY EXECUTION. I HAVE CAREFULLY READ THIS DOCUMENT, UNDERSTAND ITS CONTENT AND SIGN IT OF MY OWN FREE WILL.
